FINDINGS OF FACT

1. On June 22, 2006, McLeodUSA Telecommunications Services, Inc. ("McLeodUSA") filed tariff revisions to increase the maximum and current rates for Wire Care for business customers served by McLeod's switch and for the OneLine Preferred Package for residential customers.

2. In this filing, McLeod proposes to increase its maximum monthly charge and actual monthly charge for Wire Care from \$4.00 to \$6.25 and to increase the maximum monthly charge and actual monthly charge for OneLine Preferred Package from \$19.95 to \$28.95:



1 3. The Commission, having reviewed the tariff pages (copies of which are contained in

5 IT IS THEREFORE ORDERED that the filing be and hereby is approved.


6 IT IS FURTHER ORDERED that this Decision shall become effective immediately.
