PROCEDURAL ORDER

BY THE COMMISSION:

On April 12, 2006, the Commission issued Decision No. 68658 granting a request by Tacna Water Management Company ("Tacna" or "Company") for an increase in rates and for financing approval. Decision No. 68658 ordered the Company to make several compliance filings.

On June 30, 2006, the Company filed a request for an extension of time to make certain compliance filings required by Decision No. 68658.

On June 30, 2006, the Company also filed a copy of the Company's new rate schedule.

On September 8, 2006, the Company filed a different rate schedule from that filed on June 30, 2006, stating that the September 8, 2006 filing included a copy of the rate schedule actually mailed to its customers.

The Commission's Utilities Division Staff should file a response to the Company's April 12, 2006 request for extension of time, in order to inform the Commission's consideration of the request.

IT IS THEREFORE ORDERED that the Commission's Utilities Division Staff shall file, by November 1, 2006, a report on Tacna Water Management Company's June 30, 2006 request for an extension of time to make certain compliance filings required by Decision No. 68658.

IT IS FURTHER ORDERED that the Staff Report shall list the compliance requirements required by Decision No. 68658 and whether Tacna Water Management Company has complied with each of the requirements.

1 IT IS FURTHER ORDERED that the Staff Report shall include the Commission's Utilities  
2 Division Staff's recommendations to the Commission regarding Tacna Water Management  
3 Company's June 30, 2006 request for an extension of time to make the compliance filings required by  
4 Decision No. 68658.

5 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive  
6 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


