JOINT MOTION TO SUSPEND HEARING SCHEDULE



The reason for this request is to permit Qwest and the Joint CLECs to have more time to evaluate the testimony which the parties have filed and which will be filed this week, in order to identify issues, and to explore the possibility of a resolution. Qwest and Joint CLECs are currently having discussions in Minnesota which may lead to resolution of some of the issues between them. The Joint CLECs and Qwest are authorized by Staff to state that Staff does not object to the suspension of the hearing schedule for up to 90 days. Staff will review and comment upon any proposed resolution put into the


