**MOTION FOR WAIVER OF AAC R14-2-1105.D.**

NEUTRAL TANDEM-ARIZONA, LLC ("Applicant") respectfully requests a waiver of A.A.C. R14-2-1105.D., which requires "the procurement of a performance bond sufficient to cover any advances or deposits the telecommunications company may collect from its customers."

As indicated in Tariff No. 1, Section 2.13, page 22; Tariff No. 2, Section 2.8.7, page 27; and Tariff No. 3, Section 2.5.3 and 2.5.4, page 14, Applicant will not charge its Arizona customers for any prepayments, advances, or deposits before services and facilities are furnished. If in the future the Company desires to charge prepayments, advances, or deposits, it will file information with the Commission that demonstrates the Company's financial ability.

Accordingly, NEUTRAL TANDEM-ARIZONA, LLC hereby respectfully requests a waiver of A.A.C. R14-2-1105.D., which requires the procurement of a performance bond and an Order reflecting the same.
