PROCEDURAL ORDER

BY THE COMMISSION:

On April 11, 2005, the Commission issued Decision No. 67745. Decision No. 67745 adopted a settlement agreement between the Commission's Utilities Division Staff ("Staff") and Qwest LD Corporation ("QLDC") and its affiliates. QLDC is an affiliate of Qwest Corporation ("Qwest"). Decision No. 67745 also ordered Staff to commence a generic investigation and rulemaking proceeding to address the filing requirements and tariff obligations of interexchange carriers.

The above-captioned generic docket was opened on May 6, 2005. The terms and conditions of the settlement agreement adopted by Decision No. 67745 provided that Qwest agreed to file intrastate long distance service tariffs and/or price lists in Arizona consistent with Staff's interpretation of Commission rules on an interim basis and without prejudice pending conclusion of the generic docket or further order of the Commission. The terms and conditions of the approved settlement agreement also included an agreement between Staff and Qwest that the generic docket would be concluded within 18 months of Decision No. 67745, and an agreement by Staff that any new or additional filing requirements defined in the generic docket will have application to Qwest on only a going forward basis from the date of the final order in the generic docket.

On October 18, 2006, Qwest and Staff requested a telephonic procedural conference, which was held on that date. Qwest and Staff appeared through counsel, and agreed to an extension of time in this docket. During the telephonic procedural conference, Qwest and Staff agreed to the filing of a Staff Report in this generic docket on December 19, 2006.

1 IT IS THEREFORE ORDERED that Staff shall file a Staff Report in this docket on or before
2 December 19, 2006.


