RE: **UPDATE - IN THE MATTER OF THE APPLICATION OF COMTECH21, LLC TO EXTEND THEIR CERTIFICATE OF CONVENIENCE AND NECESSITY FOR RESOLD LONG DISTANCE (DOCKET NO. T-04080A-04-0034)**

On January 21, 2004, ComTech21, LLC ("Comtech21") submitted to the Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience and Necessity ("Certificate") to provide resold and facilities-based local exchange telecommunications services within the State of Arizona ("Application").

On January 22, 2004, the Commission's Utilities Division staff ("Staff") filed a letter, which indicates that ComTech21, LLC's application has not meet the sufficiency requirements as outlined in the Arizona Administrative Code and lists those outstanding items to be provided by ComTech21.

ComTech21 submitted information to the Commission on March 23, 2004, March 29, 2004, April 12, 2004, and May 7, 2004. By Procedural Order issued August 24, 2004, Staff was ordered to file a Status Report on ComTech21's application. On September 13, 2004, Staff sent ComTech21 a Second Set of Data Requests. On November 8, 2004, ComTech21 submitted a request for extension of time to submit its Responses to Staffs Data Requests.

On November 18, 2004, ComTech21 submitted its responses to Staff's Data Requests. There have been no filings since that time. By Procedural Order issued October 3, 2006, Staff was ordered to file an update on ComTech21, LLC's application with any appropriate recommendation no later than October 30, 2006.

This matter has recently been reassigned. Therefore, Staff recommends that this Docket remain open. Staff expects to file a Staff Report in this matter no later than January 31, 2007.
