Received statement of proposed rate increase which received gas price update form as well. It states that falling wholesale gas prices lead to lower costs this winter. But an other hand want to charge \$1100p instead of \$7.00 during period of December thru March when usage is high. This is over a 50% increase in monthly customer service charge instead of the proposed per say 21% they state. Now for period of April thru November the rate from \$7.00 to \$20.00 per month customer charge that is almost a 300% increase during the period of less gas usage. If that is a lower gas price cost than where is the extra money going unless it is to pay for the lesser advantaged to help with their gas bills. If they can increase than why can't the customers ask for a 300% inflation increase in wages.
