BY THE COMMISSION:

FINDINGS OF FACT

1. Southwest Gas Corporation ("Southwest") is engaged in providing natural gas service within portions of Arizona, pursuant to authority granted by the Arizona Corporation Commission.
2. On November 3, 2006, Southwest filed for Commission approval of an extension of a special gas procurement agreement ("SGPA") with Tucson Electric Power Company ("TEP"). TEP uses natural gas to generate electricity.
3. Southwest has served TEP through SGPAs for a number of years, under provisions of Schedule G-30, Optional Gas Service.
4. In Decision No. 68390 (January 5, 2006), the Commission approved the most recent SGPA between Southwest and TEP.
