The following information is in response to your inquiry regarding the above docket to cancel Payroll Advance Inc. dba/The Phone Connection CC&N to provide telephone services in the State of Arizona.

JFB1-1

Payroll Advance, Inc.dba, The Phone Connection decision to discontinue telephone service in the State of Arizona was due to the lack of customer base, we did not have or planned to have an active advertising program, we did not have local representation and our ILEC did not have a competitive advantage.

JFB1-2

Copies of our original letters are enclosed for your review.

JFB1-3

Payroll Advance, Inc.dba, The Phone Connection did not send out a notice as we had no active customers at the time decision was made to discontinue service.

JFB1-4

Payroll Advance, Inc.dba, The Phone Connection did not collect deposits or have prepayments or have outstanding advances that needed to be returned to customers.

JFB1-5

Payroll Advance, Inc.dba, The Phone Connection did not collect deposits.
This subsection is not applicable.

JFB1-6

Payroll Advance, Inc.dba, The Phone Connection did not provide a list as we had no active customers at the time decision was made to discontinue service.

Payroll Advance, Inc.dba, The Phone Connection does not have any facilities in the State of Arizona


JFB1-14
