On January 23, 2006, Lucky Hills Water Company ("Company") filed an application with the Arizona Corporation Commission ("Commission") for an extension of its Certificate of Convenience and Necessity ("Certificate"). If the application is granted the Company would be the exclusive provider of water service within the requested extension area, and would be required to provide service on the terms and conditions as established by the Commission.

The application is available for inspection during regular business hours at the offices of the Commission in Phoenix, at 1200 West Washington Street, Phoenix, Arizona, and in Tucson, at 400 West Congress St., Suite 218, Tucson, Arizona and at the offices of the Applicant, Lucky Hills Water Company, P.O. Box 309, Tombstone, AZ 85638. The application is also available on the Commission's website, www.azcc.gov using the e-Docket link.

The Commission will hold a hearing on this matter on January 11, 2007 at 1:30 p.m., or as soon thereafter as is practical, at the Commission's Tucson offices, Room 222, 400 West Congress, Tucson, Arizona 85701.

The law provides for an open public hearing at which, under appropriate circumstances, interested persons may intervene in the proceedings and participate as a party. You may have the right to intervene in the proceeding. Intervention will be in accordance with A.A.C. R14-3-105, except that all motions to intervene must be filed on or before December 29, 2006. Persons desiring to intervene must file a written motion to intervene with the Commission and send such motion to Applicant or its counsel and to all parties of record. The motion must, as the minimum, contain the following:

1. The name, address, and telephone number of the proposed intervenor and of any

duly sworn, deposes and says: That (he) (she) is the Agent to the Publisher of the SIERRA VISTA HERALD and the BISBEE DAILY REVIEW newspapers printed and published six days a week in the County of Cochise, State of Arizona, and of general circulation in the cities of Sierra Vista and Bisbee, County of Cochise, State of Arizona and elsewhere, and thehereto attached
