PROCEDURAL ORDER

**BY THE COMMISSION:**

On September 30, 2005, the Arizona Corporation Commission ("Commission") issued Decision No. 68190 which approved the applications of Cave Creek Water Company ("Company" or "Applicant") for extensions of its Certificate of Convenience and Necessity ("Certificate") to provide public water utility service to Parcel Nos. 216-29-0024 (Parcel 216) and 211-99-006 ("Parcel 211") in Maricopa County, Arizona. As a condition of the Commission's approval, the Company was to file copies of the main extension agreements between the Company and the respective developers of Parcels 216 and 211 by September 30, 2006.

On September 29, 2006, the Company filed a Motion requesting a 30-day extension, until October 30, 2006, in order to file a copy of the Company's main extension agreement with the developer of Parcel 211 and a 90-day extension, until December 30, 2006, to file a copy of the Company's main extension agreement with the developer of Parcel 216. The Company requested these brief extensions due to delays in completing the agreements with the developers.

On October 5, 2006, by Procedural Order, the Commission's Utilities Division ("Staff") or any interested party was ordered to file their Response to this Motion by no later than October 13, 2006.

On October 13, 2006, Staff filed a Memorandum which states that Staff has no objections to


1 the Company's request based on copies of letters from the developers of Parcels 211 and 216 which  
2 state that they are proceeding with the development of their parcels. No other parties filed a  
3 Response.

4 Accordingly, the Company's request for an extension of time of 30 days for Parcel 211, until  
5 October 30, 2006, and for an extension of time of 90 days for Parcel 216, until December 30, 2006, to  
6 file copies of the main extension agreement(s) with the respective developer(s) is reasonable and  
7 should be granted.

8 IT IS THEREFORE ORDERED that Cave Creek Water Company shall have until October  
9 30, 2006, to file a copy of its main extension agreement with the developer of Parcel 211.

10 IT IS FURTHER ORDERED that Cave Creek Water Company shall have until December 30,  
11 2006, to file a copy of its main extension agreement with the developer of Parcel 216.
