

Under appropriate circumstances, interested parties may intervene in the proceedings and participate as a party. Intervention shall be in accordance with A.A.C. R14-3-105, except that all motions to intervene must be filed within twenty (20) days of the date of this notice. You may have the right to intervene in the proceeding, or you may make a statement for the record. 

