On October 17, 2006, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity of Hearing ("Notice") against John E. and Christine M. Tencza, husband and wife, American Elder Group, L.L.C. ("AEG"), American Elder Group, Inc. ("AEGI"), Phillip R. and Mary E. Ohst, husband and wife, Gregory G. and Gail A. Groh, husband and wife, (collectively "Respondents"), in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of investment
