PROCEDURAL ORDER

BY THE COMMISSION:

On April 12, 2006, the Commission issued Decision No. 68658 granting a request by Tacna Water Management Company ("Tacna" or "Company") for an increase in rates and for financing approval. Decision No. 68658 ordered the Company to make several compliance filings.

On June 30, 2006, the Company filed a request for an extension of time to make certain compliance filings required by Decision No. 68658.

On October 17, 2006, a Procedural Order was issued directing the Commission's Utilities Division ("Staff") to file, by November 1, 2006, a response to the Company's April 12, 2006 request for extension of time, in order to inform the Commission's consideration of the request.

On October 25, 2006, Staff filed a memorandum recommending that an extension of time be granted until December 1, 2006 for the Company's filing of the Arizona Department of Environmental Quality Certificate of Approval to Construct required by Decision No. 68658. Staff's memorandum further recommended an extension of time to December 31, 2006 for the Company to comply with the requirement that the Company either file copies of its corrected tax returns for the last three years, or documentation of its corporate dissolution, as required by Decision No. 68658.

An extension of time until December 31, 2006 for the Company to comply with the requirements of Decision No. 68658 as requested by the Company in its June 30, 2006 request is reasonable and should be granted.



1 IT IS THEREFORE ORDERED that the time for Tacna Water Management Company to
2 comply with the requirement that it either correctly file its tax returns as a corporate entity, correcting
3 for the last three tax years, or file for dissolution of the corporate status with the Corporations
4 Division and make the utility a sole proprietorship, and file with Commission Docket Control as a
5 compliance item in this docket either copies of the corrected tax returns or documentation of its
6 corporate dissolution, is hereby extended to December 31, 2006.

7 IT IS THEREFORE ORDERED that the time for Tacna Water Management Company to
8 comply with the requirement that it file, as a compliance item in this docket, a copy of the Arizona
9 Department of Environmental Quality Certificate of Approval to Construct for the water treatment
10 system improvements necessary to meet the new EPA MCL for arsenic, is hereby extended to
11 December 31, 2006.

12 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
13 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
