A MOTION TO INTERVENE FOR MARSHALL MAGRUDER

As provided by the Procedural Order for these cases of 8 September 2006, Marshall Magruder, a Santa Cruz County UNS Gas, Inc. customer, respectfully requests to intervene in these combined cases. Some of the areas of interest include:

- a. The proposed residential Service Charge increase of 340% in less than four years from \$60.00 per year prior to 11 August 2003, to the present \$84.00 per year, and a proposed \$204.00 per year.
- b. The proposed natural gas rates for many Schedules that show customer savings for higher monthly usage per therm instead of a rate increase which is counter-initiative to both Demand Reduction and basic conservation principles.
