1 The Securities Division ("Division") of the Arizona Corporation Commission through its
2 attorney, William W. Black, Respondents Phillip and Mary Ohst ("Ohst Respondents"), through
3 their attorney, Sherman D. Fogel, and John Tencz and Christine Tencza, American Elder Group,
4 LLC, and American Elder Group, Inc. ("Tencza Respondents") through their attorney, Brian
5 Hendrickson, have agreed to postpone indefinitely the pre-hearing conference currently set for
6 December 5, 2006 at 9:30 a.m.

8 On October 17, 2006, the Division filed a Notice of Opportunity for Hearing Regarding
9 Proposed Order to Cease and Desist, for Restitution, for Administrative Penalties, and for other
10 Affirmative Action against Respondents in which the Division alleged multiple violations of the
11 Arizona Securities Act in connection with the offer and sale of securities in the form of investment
12 contracts. Respondents were duly served with copies of the Notice.

13 On October 31, 2006, the Ohst Respondents filed a Request for Hearing.

14 On October 30, 2006, the Tencza Respondents filed a Request for Hearing.

15 On November 9, 2006, by Procedural Order, a pre-hearing conference was scheduled for
16 December 5, 2006.

17 The Division has granted the Ohst Respondents an open extension of time to file an
18 answer to enable the Division and the Ohst Respondents to discuss their respective positions and
19 explore whether a settlement can be reached.






