RE: **STAFF REPORT** - IN THE MATTER OF THE APPLICATION OF APP
TELEMANAGEMENT LLC FOR A CANCELLATION OF THEIR CERTIFICATE
OF CONVENIENCE AND NECESSITY FOR CUSTOMER OWNED PAY
TELEPHONE SERVICE (DOCKET NO. T-03758A-04-0021)

On January 15, 2004, APP Telemanagement LLC filed an application to cancel its Certificate of Convenience and Necessity ("CC&N") to provide customer owned pay telephone ("COPT") service in Arizona. Staff contacted the Management Contact of Record, Steve Jurich on July 27, 2006 and verified that he is the authorized person that made the Application. Mr. Jurich stated that he has not provided COPT service since 2002. In addition, Mr. Jurich reported that he sold some of his COPT equipment several years ago and has some of his COPT equipment in storage. Mr. Jurich stated that he does not want a hearing to cancel this CC&N.

The Compliance Section of the Utilities Division indicates that APP Telemanagement LLC does not have any outstanding compliance issues that need to be addressed with the Commission. The Consumer Services Section of the Utilities Division reported that from January 1, 2003 through July 21, 2006 there were no consumer complaints, inquiries or opinions filed against APP Telemanagement LLC. Also, the Corporations Division of the Commission states that the APP Telemanagement LLC is in good standing.

Staff further recommends approval of the request to cancel Mr. Jurich's CC&N. Upon cancellation of its CC&N, APP Telemanagement LLC will not be authorized to provide COPT telecommunications services in Arizona and therefore, will not have to meet any of the requirements of Decision No. 62019.
