PROCEDURAL ORDER

**BY THE COMMISSION:**

On November 15, 2006, the City of Maricopa ("City") filed with the Arizona Corporation Commission ("Commission") a request for approval for the Union Pacific Railroad ("Railroad") to upgrade a crossing at the Railroad's tracks at Porter Road in Maricopa, Arizona at AAR/DOT No. 741-345R.

IT IS THEREFORE ORDERED that the request of the Arizona Department of Transportation shall be considered an application for the Railroad to construct a new public railroad crossing pursuant to A.R.S. § 40-337, et seq.

IT IS FURTHER ORDERED that the **hearing** on the application shall be held on **January 3, 2007, at 9:45 a.m.**, or as soon thereafter as is practical, at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.

IT IS FURTHER ORDERED that within five business days of receipt of this Procedural Order, **THE CITY OF MARICOPA SHALL PROVIDE THE RAILROAD AND ANY OTHER MUNICIPALITY OR INTERESTED PARTY** that may be affected by the application with a copy of the application and this Procedural Order by certified mail.


