**STAFF NOTICE OF FILING
RECOMMENDED SCHEDULE
CHANGES**

On May 1,2006, Utility Source, LLC ("Utility Source" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for a determination of the current fair value of its utility plant and property and for increases in its rates and charges for water and wastewater utility service provided to customers in the Company's service area in Coconino County, Arizona.


Citing discovery issues, Commission Staff ("Staff") filed a motion requesting extension of the filing deadline for its direct testimony by sixty days. Pursuant to a procedural order of November 8, 2006, Staff's motion requesting extension of its filing deadline was granted. As a consequence of this time extension, various other deadlines would also be affected. Following discussion between Staff and counsel for the Company, both parties recommend the following adjustment of the schedule to conform with the deadline extension. Further, Mr. Starr Lanphere of the Ponderosa Fire District was consulted separately by Staff on the recommended schedule and had no objections.

Staff's and Interveners' Direct Testimony and Exhibits should now be due on or before January 16, 2007. The Company's Rebuttal Testimony and Exhibits should now be due on or before February 16, 2007. Staff's and Interveners' Surrebuttal Testimony and Exhibits should now be due on or before March 5, 2007. The Company's Rejoinder Testimony and Exhibits should now be due on or before March 27, 2007. The pre-hearing conference should now be moved to March

1 30, 2007. The evidentiary hearing should now be scheduled for April 3, 2007 through April 4,
2 2007.

3 As the originally scheduled hearing date of January 22, 2007 at 10:00 a.m. has been publicly
4 noticed, Staff and the Company recommend that the scheduled hearing should be held solely to
5 receive public comments. Utility Source also agrees to a suspension of the time-clock for 75 days.
