PROCEDURAL ORDER

BY THE COMMISSION:

On December 30, 2005, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and a Notice of Opportunity for Hearing ("Notice") against Reserve Oil & Gas, Inc. (ROG"), Allen and Jane Doe Stout, Sr., and Allen and Jane Doe Stout, Jr. (collectively "Respondents"), in which the Division alleged that the Respondents committed multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of investment contracts. As a result of the T.O., the Respondents were immediately ordered to cease and desist from violating the Act.

Respondents were duly served with copies of the Notice.


On January 19, 2006, Respondents filed a request for hearing. After several pre-hearing conferences, a hearing was scheduled for November 7, 2006, but was continued.

On November 9, 2006, Respondents filed a Motion to Set a Settlement Conference and requested that Assistant Chief Administrative Law Judge, Dwight Nodes preside over the proceeding. The Division did not oppose Respondents' Motion.

1 Accordingly, a Settlement Conference should be scheduled.

2 IT IS THEREFORE ORDERED that a **settlement conference** shall be held on **December 13,**  
3 **2006, at 10:30 a.m.**, at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona  
4 before Assistant Chief Administrative Law Judge Dwight Nodes.
