Dear Utility Customer:

You were previously notified that the Arizona Corporation Commission ("Commission") had issued a conditional Order granting an application for the transfer of AUSS's assets and service area to Johnson Utilities Company ("JUC") upon fulfillment of certain conditions. Those conditions have now been met, and the Commission has issued a FINAL ORDER on October 20, 2006, that finalized the transfer. A copy of this Decision is on file at the Commission.

JUC's Commission approved tariff rate for residential wastewater utility service is \$38.50 per month. The Commission's FINAL ORDER authorized JUC, effective November 1, 2006, to charge its current rates and charges to all former customers of AUSS. You will receive a wastewater service agreement in the mail with your first bill from JUC. The wastewater service agreement will need to be filled out and returned to JUC in the mail with your first payment to maintain service.

YOUR RATE CHANGE WILL BECOME EFFECTIVE NOVEMBER 1, 2006.

JUC is confident that this increased cost will be mirrored by a higher level of customer support and service. Further, the transfer will eliminate the numerous health and safety related concerns associated with The Links wastewater treatment plant. The transfer will eliminate the need for The Links wastewater treatment plant.
