PROCEDURAL ORDER

BY THE COMMISSION:

On October 6, 2006, the Arizona Corporation Commission ("Commission") Staff filed a Complaint and Petition for an Order to Show Cause ("Complaint") against Carl Harvey, dba Golden Corridor Water Company ("GCWC") for failure to comply with Commission Rules and Regulations.

On December 5, 2006, the Commission issued Decision No. 69166 which directed the Hearing Division to conduct an evidentiary hearing in this matter.

IT IS THEREFORE ORDERED that a pre-hearing conference shall commence on **December 11, 2006, at 10:00 a.m.**, at the Commission's offices, 1200 West Washington, Phoenix, Arizona 85007.
