

RE: CAAG 208 Areawide Water Quality Management Plan Amendment for Palo Verde Utilities Company Southwest Water Reclamation Facility (WRF)

The Central Arizona Association of Governments has reviewed the proposed CAAG 208 Areawide Water Quality Management Plan Update Amendment for the Palo Verde Utilities Company (PVUC) Southwest Water Reclamation Facility, submitted by PVUC, and their engineer, Kennedy/Jenks Consultants. The plan received an initial and final review in concert with the Arizona Department of Environmental Quality.

The amendment was advertised locally and made available to the public. On November 1, 2005, a Public Hearing was held, and no negative comments were received. The amendment was reviewed by the CAAG Environmental Planning and Management Committees. Both groups recommended approval to the Regional Council. On November 16, 2005, the CAAG - Region V Council approved the amendment to the CAAG AWWQMP Update (1994). The State Water Quality Working Group reviewed the plan on December 13, 2005, and approved it for consideration by ADEQ and the Governor of the State of Arizona.

Enclosed are five copies of the CAAG 208 AWWQMP Amendment for the PVUC Southwest WRF. CAAG respectfully submits this plan for consideration by the Arizona Department of Environmental Quality and the Environmental Protection Agency.
