On December 6, 2006, Qwest Corporation ("Qwest") and DIECA Communications, Inc. d/b/a Covad Communications Company ("Covad") submitted a brief (1) addressing whether there is a further need for the Phase II pricing proceeding ordered by the Commission in the Commission's Arbitration Order issued February 2, 2006 and (2) requesting approval of an amendment to the parties' arbitrated interconnection agreement implementing the FCC's Triennial Review Remand Order ("TRRO").

The Commission's Staff was ordered to provide a response to Qwest's filing by January 12, 2007. The Staff member responsible for this matter has been out of the country for several weeks and just returned. Staff, therefore, requests an extension of time until January 24, 2007 to submit its response to Qwest's filing.




