CONCERNING MAILING OF
NOTICE TO PROPERTY OWNERS**

12 On January 12, 2007 at 1:30 pm, a short telephonic procedural conference was held
 13 to discuss the deadline for mailing the Notice of Hearing ("Notice") to property owners
 14 within Desert Hills Water Co., Inc.'s ("Desert Hills") service area, consistent with the
 15 procedural order issued on December 27, 2006. Present during the teleconference were
 16 counsel for Desert Hills and Commission Staff. Counsel for Renaissance Partners, L.L.C.
 17 was made aware of the teleconference, but was not able to participate.

18 Counsel for Desert Hills explained that as of the morning of January 12, 2007, the
 19 company had identified roughly 3,000 property owners within its service area. Because of
 20 the time involved in identifying the parcels and property owners of record, it was not
 21 possible that each and every Notice would be mailed prior to the deadline. Counsel for
 22 Desert Hills requested an extension to January 16, 2006 to mail any remaining Notices
 23 that were not mailed on January 12, 2006. Staff counsel did not oppose Desert Hills'
 24 request, and Administrative Law Judge Farmer granted the request.


