PROCEDURAL ORDER

10 **BY THE COMMISSION:**

11 On May 1, 2006, Utility Source, LLC ("Utility Source" or "Company") filed with the Arizona
12 Corporation Commission ("Commission") an application for a determination of the current fair value
13 of its utility plant and property and for increases in its rates and charges for water and wastewater
14 utility service provided to customers in the Company's service area in Coconino County, Arizona.

15 By Procedural Order issued July 10, 2006, a hearing in this matter was scheduled for January
16 22, 2007, and other procedural deadlines were established.

17 On November 8, 2006, a Procedural Order was issued granting a request by the Commission's
18 Utilities Division Staff ("Staff") to extend the deadline for filing its Direct Testimony, until January
19 15, 2007.

20 On November 30, 2006, Staff filed a Notice of Recommended Schedule Changes, including a
21 change of the current hearing date and other previously established procedural deadlines. By
22 Procedural Order issued December 20, 2006, Staff's request was granted and the hearing date and
23 other procedural deadlines were amended.

24 On January 10, 2007, Staff filed a Motion for Extension of Deadline, requesting that the
25 current January 16, 2007 due date for its Direct Testimony be extended until January 19, 2007.

26 On January 12, 2007, the Company filed a Response stating that it does not oppose Staff's
27 request for an extension of the filing deadline for its Direct Testimony.

1 IT IS THEREFORE ORDERED that Staff's request for an extension of time to file its Direct
2 Testimony is granted. Staff and intervenor Direct Testimony shall be filed by no later than January
3 19, 2007.

4 IT IS FURTHER ORDERED that in all other respects that December 20, 2006 Procedural
5 Order shall remain in full force and effect.

6 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113-Unauthorized
7 Communications) continues to apply to this proceeding as the matter is now set for public hearing.

8 IT IS FURTHER ORDERED that all parties must comply with Rule 33 (c) and (d) of the
9 Rules of the Arizona Supreme Court with respect to practice of law and admission pro hac vice.

10 IT IS FURTHER ORDERED that withdrawal of representation must be made in compliance
11 with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Rule 42 of the
12 Rules of the Arizona Supreme Court). Representation before the Commission includes the obligation
13 to appear at all hearings and procedural conferences, as well as all Open Meetings for which the
14 matter is scheduled for discussion, unless counsel has previously been granted permission to
15 withdraw by the Administrative Law Judge.

16 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,
17 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
18 hearing.
