BY THE COMMISSION:

FINDINGS OF FACT

1. Southwest Gas Corporation ("Southwest") is engaged in providing natural gas service within portions of Arizona, pursuant to authority granted by the Arizona Corporation Commission.

2. On November 24, 2006, Southwest filed for Commission approval of revisions to its rate schedule number T-1, Transportation of Customer-Secured Natural Gas.

3. Southwest cites a need to conform its tariff to recent changes implemented by El Paso Natural Gas Company on its interstate pipeline system.

4. Given the date of this filing and the issues raised by Southwest's filing, Staff has not had time to properly analyze the filing.

5. Staff has recommended that the Commission suspend this tariff filing for one hundred twenty (120) days, through and including April 24, 2007.

CONCLUSIONS OF LAW

2 1. Southwest is an Arizona public service corporation within the meaning of Article  
3 XV, Section 2, of the Arizona Constitution.

4 2. The Commission has jurisdiction over Southwest and over the subject matter of the  
5 application.

6 3. The Commission, having reviewed the application and Staff's Memorandum dated  
7 November 30, 2006, concludes that it is in the public interest to suspend the filing.

9 IT IS THEREFORE ORDERED that this filing be and is hereby suspended through  
10 April 24, 2007.

11 IT IS FURTHER ORDERED that this Order shall become effective immediately.


