**MOTION FOR ACCELERATED  
PROCEDURAL SCHEDULE**

**(Expedited Ruling Requested)**

Comcast Phone of Arizona, LLC ("Comcast") requests an accelerated procedural schedule in this docket. In support of this motion, Comcast states:

1. Counsel for Comcast may have a conflict with the March 1, 2007 hearing. Counsel is representing Tucson Electric Power Company in Docket No. E-01933A-05-0650. The hearing in that docket commences on February 20, 2007 and may continue through the following week, including March 1<sup>st</sup>.

2. The application for a competitive telecommunications CC&N in this docket has been pending since 2004. Comcast is prepared to commence service promptly upon the grant of the CC&N, thus increasing facilities-based competition in Arizona.

3. The application in this docket requests a competitive telecommunications CC&N. Hearings on such applications typically last less than one hour. Comcast is flexible with respect to the time of day set for the hearing in order to increase the availability of a hearing room. With a slightly accelerated schedule, an expedited transcript and a waiver of the 10-day period for exceptions, Comcast would like the matter to be included on the March 13, 2007 Open Meeting agenda.
