MOTION FOR EXTENSION OF
DEADLINE

On May 1, 2006, Utility Source, LLC ("Utility Source" or "Company") filed an application for a determination of the current fair value of its utility plant and property and for increases in its rates and charges for water and wastewater utility service with the Arizona Corporation Commission ("Commission").

On November 8, 2006, a Procedural Order was issued granting a request by the Commission's Utilities Division Staff ("Staff") to extend the deadline for filing its Direct Testimony, until January 16, 2007.

During various exchanges between the Company and Staff, the Company indicated that certain engineering costs related to water testing were insufficient in light of the Company's proximity to a superfund site. Staff requested and received invoices indicating water testing costs were more than double what Staff had determined as part of developing the engineering report. Staff incorporated the costs supported by the invoices into the water division's water testing costs.

However, on further investigation, Staff communicated with the laboratory performing the water testing and was informed that, though labeled on invoices as water testing costs, the tests are in fact wastewater testing costs. For the purposes of the Company's application, these costs should have been attributed to the sewer division of the Company rather than the water division.

1 Owing to the consequent changes that correcting the error will have on the accounting
2 schedules, Staff requests three additional business days to file its direct testimony which would now
3 be due January 19, 2007.
