The rate increase request by UNS gas is unwarranted at the present time. This company is gaining thousands of customers at very little cost due to high density "in-fill" home construction in this area. Their cost per customer must be at an all time low. They over-collected millions of dollars on the adjustment you granted recently. They put a piece in the local newspaper stating they would refund the overage on future bills but made no mention of what would become of the earnings of this money. That money also belongs to the people who overpaid and should be included in the settlement. The customer charge is high at the present rate as most of the cost of the equipment this is supposed to cover has probably been recovered many times over. I don't think customers should have to pay for poor management or "creative" bookkeeping. No one begrudges a company a fair return on investment but when that company is serving twice as many customers with basically the same infrastructure, a twenty percent increase in any part of their rate structure is preposterous. Thank you for your careful consideration of this action that, if approved, will create a hardship for thousands of people.
