
**MOTION TO EXTEND DUE DATE FOR RESPONSIVE BRIEFS**

Arizona Corporation Commission ("Staff") hereby requests an extension of the due date for filing responsive briefs in this matter. Responsive briefs are currently due on February 5, 2007; Staff seeks to extend that deadline to February 16, 2007.

The opening briefs in this proceeding, filed on January 22, 2007, were somewhat longer than usual, presumably due to the length of the hearing and the corresponding length of the record. APS' brief, for example, is approximately 180 pages long. Responding to these briefs within the two-week time frame provided in the current procedural schedule will be very difficult for the Legal Division given current work loads and resource constraints.

1 For this reason, Staff respectively requests that the Commission extend the deadline for filing  
2 responsive briefs until February 16, 2007. Staff also requests expedited consideration of this motion.
