






10 On October 25, 2006, issued Decision No. 68235 which granted Johnson Utilities Company an
11 extension of its CCN to provided public water and wastewater utility service to various parts of
12 Pinal County, Arizona. During December 12, 2006, procedural conference, JUC indicated that,
13 having obtained the required performance bond, the Company is now in full compliance with
14 Decision No. 68235 and therefore the docket should be closed. Staff agreed with JUC's request to
15 close the docket based on the Company's compliance with the prior Decision.

14 Per Procedural Order issued on January 24, 2007, by Dwight D. Nodes Administrative Law Judge,
15 the Company's Application for Administrative Closure is hereby granted and accordingly,
