

 Mountain Telecommunications of Arizona, Inc. ("MTI") filed an application with the Arizona Corporation Commission ("Commission") on December 8, 2006 (the "Application"), requesting a limited waiver of the Public Utility Holding Companies and Affiliated Interests Rules, AAC R14-2-801 to R14-2-806, in relation to the guarantee of certain financing arrangements previously entered by its affiliate, Eschelon Operating Company. In the alternative, MTI requests approval of the guarantee pursuant to AAC R14-2-804. Furthermore, MTI requests approval of the encumbrance of its Arizona assets pursuant to A.R.S. § 40-285. For the reasons set forth in the Application, MTI submits that approval of the Application is in the public interest. The Application is available for inspection during regular business hours at the offices of the Commission located at 1200 West Washington Street, Phoenix, Arizona 85007; and at the office of MTI's legal counsel, Lewis and Roca LLP, 40 North Central Avenue, Suite 1900, Phoenix, Arizona 85004. The Commission may grant the Application without a hearing.
