

**Compliance Item:**

Decision No. 68310 dated November 14, 2005 in WS-01303A-05-0280 et al. states, "IT IS FURTHER ORDERED that, for the Havasu District, Arizona-American Water Company shall file with Docket Control by January 31<sup>st</sup> of each year, an annual calendar year status report, until the AIF Tariff is no longer in effect. The status report shall contain a list of all customers that have paid the AIF, the amount each customer has paid, the amount of money spent from the AIF, and a list of all facilities that have been installed with funds from the AIF Tariff during the 12-month period."

**Response:**

Attached is a schedule displaying the amount paid, date paid and payee of the Havasu Arsenic Impact Fee for 2006 and to-date.

The entire proceeds of the Havasu Arsenic Impact Fee were spent on the single arsenic removal facility in Havasu district placed in service in March 2006. All Havasu AIF proceeds are applied as a contribution in aid of construction of this facility.
