
**MIDVALE TELEPHONE
EXCHANGE, INC.'S NOTICE OF
COMPLIANCE**

On November 10, 2003, the Commission issued Decision 66510 in the above entitled proceeding. Decision 66510 required, *inter alia*, that Qwest Corporation ("Qwest"), Midvale Telephone Exchange, Inc. ("Midvale") and Table Top Telephone Company ("Table Top") submit documentation so that Staff can evaluate the costs associated with implementing extended area service ("EAS") between the three named companies.

ORIGINAL

On December 3, 2003, Table Top filed a Notice of Compliance with Decision 66510, notifying the Commission that Table Top has withdrawn its request for two-way EAS with Qwest and Midvale. Assuming that the Commission accepts Table Top's withdrawal, the sole remaining EAS issue concerns the proposal for two-way EAS between Qwest and Midvale. Midvale previously supplied its best estimate of the cost of two way EAS between Qwest and Midvale in its late filed exhibit filed in this proceeding on September 9, 2003. Accordingly, Midvale requests that the Commission accept its September 9th, 2003 exhibit as its compliance with the Commission's order to provide the estimated costs of two-way EAS between Midvale and Qwest.


