FIFTH
PROCEDURAL ORDER

BY THE COMMISSION:

8 On September 5, 2006, the Securities Division ("Division") of the Arizona Corporation
9 Commission ("Commission") filed a Notice of Opportunity of Hearing ("Notice") against Trend
10 Management Group, Inc. ("TMG"), Scott Renny Bogue and Arlene Jane Bogue, husband and wife,
11 Ryan James Herndon and Lori Darlene Herndon aka Lori Herndon aka Lori Jordan, husband and
12 wife, Trend Capital, L.L.C. ("TCL"), Linda Bryant Jordan aka Linda Van Vranken aka Linda Jordan-
13 Van Vranken, a married woman, individually, and dba The Trend Group, Inc., Russell Langdon Van
14 Vranken, husband of Linda Bryant Jordan, Easy Street Financial Group, Inc. ("Easy Street"),
15 Christopher Ellis Marx and Jane Doe Marx, husband and wife, and Scot Alan Oglesby and Lori Ann
16 Oglesby, husband and wife, (collectively "Respondents"), in which the Division alleged multiple
17 violations of the Arizona Securities Act ("Act") in connection with the offer and sale of stock,
18 investment contracts, participation in profit-sharing arrangements, and/or evidences of indebtedness.

19 Respondents were duly served with copies of the Notice.

20 On September 12, 2006, Ryan Herndon and TCL filed a request for a hearing.

21 On September 15, 2006, TMG, Scott Bogue, Arlene Bogue, Ryan Herndon, TCL, Lori
22 Herndon, Linda Bryant Jordan-Van Vranken, and Christopher Ellis Marx filed requests for a hearing.

23 On September 26, 2006, by Procedural Order, a pre-hearing conference was scheduled for
24 November 2, 2006.

25 On October 2, 2006, Russell Van Vranken filed a request for hearing.

26 No request for hearing has been filed on behalf of Easy Street.

27 On October 4, 2006, a Revised Procedural Order noted the request for hearing by Russell Van
28

1 Vranken and that the pre-hearing conference was to take place as previously ordered.

2 On October 19, 2006, counsel for the Division filed a Motion to Continue ("Motion") the pre-
3 hearing conference due to a scheduling conflict with the Commission's Securities Open Meeting
4 which is scheduled on November 2, 2006, in Tucson and also because several Respondents named in
5 this proceeding are parties to matters to be considered at the Commission's Open Meeting. Counsel
6 for the Division indicated that counsel for the Respondents named in this proceeding have no
7 objection to the Division's Motion.

8 On October 25, 2006, by Procedural Order, the Division's Motion was granted and the pre-
9 hearing conference was continued to November 14, 2006.

10 On November 14, 2006, the Division and counsel for TMG and the Bogues, James Herndon
11 and TCL, Lori Herndon, and the Van Vrankens appeared. The Division and the parties requested that
12 a status conference be scheduled in February 2007.


13 On November 15, 2006, by Procedural Order, a status conference was scheduled for February
14 15, 2007.

15 On February 6, 2007, the Division filed a Motion to Continue the status conference scheduled
16 for February 15, 2007 citing a pending proceeding in the Maricopa County Superior Court in Case
17 No. CV2006-016822. The Division indicated opposing counsel have no objections to its Motion.

18 Accordingly, the status conference should be continued.

19 IT IS THEREFORE ORDERED that the **status conference** shall be continued from
20 **February 15, 2007, to March 22, 2007, at 9:30 a.m.**, at the Commission's offices, 1200 West
21 Washington Street, Phoenix, Arizona.


