Dear Colleagues:

AT&T recently provided written notification to its customers that it will begin charging a monthly \$1.49 In-State Connection Fee. The stated purpose of the fee is to help AT&T recover the money it pays to local telephone companies to carry in-state long distance and local toll calls over the local telephone companies' lines.

After receiving this notice, I asked Commission Staff if AT&T was authorized to charge the fee without Commission approval. In response, Staff advised me that AT&T had docketed the notice (copy attached) with a tariff filing on January 30, 2007, and that AT&T will need to obtain Commission approval before charging the fee. Staff subsequently advised AT&T of this matter in Staff's February 7, 2007 letter to the Company.

Following conventional procedures, Staff will review the tariff filing and prepare a report including Staff's recommendations for the Commission's consideration at an Open Meeting.

I hope this information may be useful in case you are contacted by concerned AT&T customers.
