STF 23.2 Two emails from Shea to Cox (CX04388 and CX04284, dated July 8, 2002 and July 9, 2002, respectively) indicate a file attachment "070402 Shea ModelJEGC.xls." The printed pages attached to the emails noted above also contain numerous pages with header information that states in part "JEB 4/4/2005." Since this information is attached to emails dated July 8 and July 9, 2002, Staff believes that the date "4/4/2005" was generated by the Excel insert date "&[Date]" function in the header which automatically generates the current date when a file is opened and printed. Staff, therefore, assumes that Cox has access to the electronic, Excel file labeled - 070402 Shea ModelJEGC.xls.

Please provide via email, or CD, a copy of the electronic, Excel file labeled - 070402 Shea ModelJEGC.xls.

RESPONSE: Attached is a CD containing the files attached to the referenced emails from Shea to Cox. Cox has designated the information on the CD as confidential because it was provided to Cox by Shea as confidential.
