Pursuant to the order of the Administrative Law Judge ("ALJ") at the Prehearing Conference held February 8, 2007 in the above-captioned dockets, Perkins Mountain Water Company and Perkins Mountain Utility Company ("the Applicants") hereby file summaries describing the areas of testimony that will be provided at the hearing by Applicants' witnesses William R. Victor, P.G., Ray L. Jones, P.E., Kirk Brynjulson and Frederick Chin. In further compliance with the order of the ALJ, the Applicants had a subpoena issued to the Arizona Department of Water Resources ("ADWR") to provide a representative to provide testimony and answer questions at the hearing. Although the Applicants expect to call the ADWR witness, the witness represents the State of Arizona and the Applicants are unable to provide a summary of his or her testimony.

Counsel undersigned was asked at the Prehearing Conference to contact Jim Rhodes and convey the Commission's request that he attend the hearing to provide

1 testimony regarding the facts and circumstances of litigation matters and settlements
2 pertaining to various affiliates of the Applicants within the Rhodes family of companies,
3 as well as information regarding their financial wherewithal. As the Applicants want the
4 most knowledgeable witness to address these issues, Mr. Rhodes has asked Mr. Frederick
5 Chin to attend the hearing to provide testimony and answer questions. Mr. Chin is Chief
6 Operating Officer of Sagebrush Enterprises, Inc., the parent company of the Applicants
7 and a former partner with Ernst & Young. He is more familiar with the litigation matters
8 and settlements pertaining to the Rhodes family of companies. He is also knowledgeable
9 regarding the financial strength of the Rhodes companies. In the event that the
10 Commission has additional questions following the testimony of Mr. Chin, a
11 determination can be made at that time as to how to address these questions.

12 Also attached is a table of exhibits to be used at the hearing. Copies of the
13 exhibits are being hand-delivered to Staff, counsel for the intervenor, and the
14 Commissioners.



TESTIMONY SUMMARY
OF
WILLIAM R. VICTOR, P.G.

William R. Victor, P.G.

Testimony Summary

William R. Victor, P.G., is a Principal of Errol L. Montgomery and Associates ("M&A"), one of the leading hydrogeologic consulting firms in the western hemisphere. Mr. Victor will testify regarding the Arizona Department of Water Resources ("ADWR") process for reviewing and approving requests for Analyses of Adequate Water Supply for master planned developments, and will discuss how that process compares to the process for reviewing and approving requests for Analyses of Assured Water Supply within active management areas. He will discuss the procedures followed by M&A in submitting the requests for Analyses of Adequate Water Supply for the Golden Valley South and the Villages at White Hills master planned developments. He will discuss the two Analyses of Adequate Water Supply issued by ADWR for Golden Valley South currently totaling 11,895 acre-feet of physically available supply.

Regarding Golden Valley South, Mr. Victor will testify as to his expert opinions and conclusions based on M&A's study and analysis of the North Sacramento Valley groundwater basin, including:

- a. Committed demand for the area;
- b. Projected water demand calculated for Golden Valley South
 - i. Groundwater demand
 - ii. Reuse of effluent
- c. Projected impacts to groundwater levels in the North Sacramento Valley groundwater basin;
- d. Compliance with ADWR criterion;
- e. Potential impacts to existing wells in the area;
- f. Groundwater physically available for Golden Valley South; and
- g. Effluent physically available for Golden Valley South.

William R. Victor, P.G.
Testimony Summary

Mr. Victor's testimony will also include explanations of the following correspondence from ADWR:

- a. 10-19-2005 Analysis of Adequate Water Supply issued from ADWR to American Land Management, L.L.C., concluding that 9,000 AF/yr of groundwater is physically available for Golden Valley South;
- b. 8-14-2006 Analysis of Adequate Water Supply issued from ADWR to American Land Management, L.L.C., concluding that 2,895.69 AF/yr of effluent is physically available for Golden Valley South; and
- c. 1-25-2007 letter from ADWR to Snell & Wilmer regarding physical availability of water for Golden Valley South.

Mr. Victor will also testify to the status of the USGS study on the aquifer.

Testimony Summary

Ray L. Jones, P.E., is principal of Aricor Water Solutions. Aricor has been retained by Perkins Mountain Water Company and Perkins Mountain Utility Company as a consultant and certified operator for the water and wastewater systems that will serve the Golden Valley South and Villages at White Hills developments in Mohave County. Mr. Jones will testify regarding the design of the water and wastewater systems. Mr. Jones will testify regarding the management and operation of each of the utilities. Mr. Jones will discuss the master plan engineering reports for the utilities and the use of effluent at the Golden Valley South and Villages at White Hills developments. Mr. Jones will testify regarding Staff's equity (capital structure) recommendation and its impact on the rate structure of the utilities. Mr. Jones will testify regarding the performance bond recommended by Staff.

Testimony Summary

Mr. Brynjulson is the President of Perkins Mountain Water Company and Perkins Mountain Utility Company (collectively, "the Companies"). He will testify regarding the organization and planned operation of the Companies. He will testify regarding the steps taken by the Companies to obtain certificates of convenience and necessity to provide water and wastewater services to the Golden Valley South and Villages at White Hills master planned developments. Mr. Brynjulson will testify regarding the water infrastructure that has been constructed to date which will be used by the Companies to provide water service, including the issuance of approvals to construct and approvals of construction by the Arizona Department of Environmental Quality. He will testify regarding changes to the Golden Valley South master plan, and the current status of various county approvals regarding the developments, including the issuance of water and wastewater franchises and 208 approval by Mohave County. Mr. Brynjulson will testify regarding the Companies' position on the recommendations of Staff contained in the Staff Report Addendum. He will also testify regarding the Companies' contracts with Aricor Water Solutions and Errol L. Montgomery and Associates.
