NOTICE OF ARSENIC REMOVAL SURCHARGE TARIFF

Dear Customers

There will be an additional charge on your water service bill it is an ARSENIC REMOVAL SURCHARGE TARIFF authorized by the Arizona Corporation Commission. The Tariff rate structure is shown below in **TABLE A**

The Arizona Corporation Commission in Decision No. 68658 authorized Tacna Water Management Company (TWMC) an Arsenic Removal Surcharge Tariff. And directed the TWMC to file an application for approval of an arsenic removal surcharge tariff that would enable TWMC to meet its principal and interest obligations on the actual amount of an improvement loan with Water Infrastructure Financing Authority ("WIFA") and pay income taxes on the surcharges. In Decision No. 69215 the Arizona Corporation Commission **approved** the application by TWMC for an Arsenic Remedial Surcharge as shown below on **TABLE A.** to service the debt necessary to complete the arsenic treatment investment.
