Dear Judge Wolfe:

I represent Qwest Communications Corporation and Qwest LD Corp. dba Qwest Long Distance (hereinafter "QCC" and "QLDC") in Docket Nos. T-02811B-01-0895 and T-04190A-03-0464 relating to the issuance of Certificates of Convenience and Necessity ("CC&Ns") for these entities. Staff has issued its reports in both dockets. QCC and QLDC recognize that standard terms normally contained in Staff reports and proposed orders are conditions that carriers file their tariffs and bond 30-days prior to beginning the commencement of service.

In this case, QLDC and QCC anticipate that the effective date of FCC 271 approval for the provision of interLata service in Arizona will occur much sooner than 30-days from the effective date of Commission Orders granting CC&Ns to QCC and QLDC. QLDC and QCC request that the proposed Orders in these matters provide that QCC and QLDC may provide service immediately after filing the required compliance tariffs and bonds. I have discussed this matter with Maureen Scott who has indicated that Staff agrees with and supports this request.

In order to have these matters ready for the December 2 open meeting, QCC and QLDC also waive the 10-day period for filing exceptions R14-3-110(B) from a proposed order granting a certificate in either docket.
