RE: IN THE MATTER OF THE APPLICATION OF D-TEL COMMUNICATIONS FOR APPROVAL OF A CANCELLATION OF CERTIFICATE OF CONVENIENCE AND NECESSITY FOR CUSTOMER OWNED PAY TELEPHONE PROVIDERS (DOCKET NO. T-03834A-06-0293)

On April 28, 2006, Virgil E. Grant, Jr. d/b/a D-Tel Communications ("Applicant") filed an Application to cancel its Certificate of Convenience and Necessity ("CC&N"). Staff contacted the Applicant on May 10, 2006 and verified that he is the authorized person that made the Application. Mr. Grant stated he no longer provides customer owned pay telephone ("COPT") services in Arizona and he is not requesting authority to sell his COPT assets. The Applicant has waived his right to a hearing and to receive notice of a hearing in order to cancel the CC&N.

The Consumer Services Section of the Utilities Division indicates that the Applicant had no complaints, inquiries, or opinions from January 1, 2003 to May 10, 2006. Also, the Applicant is in good standing with the Corporations Division of the Commission. The Compliance Section of the Utilities Division indicates that the Applicant does not have any outstanding compliance issues that need to be addressed with the Commission. Therefore, Staff recommends that the Applicant's CC&N be cancelled.

Upon cancellation of its CC&N, Virgil E. Grant, Jr. d/b/a D-Tel Communications will not be authorized to provide COPT services in Arizona and therefore, will not be required to meet any of the requirements of Decision No. 62352.
