12 Therein the Commission ordered a hearing to be conducted at a date and time set by the
13 Hearing Division.

14 By Procedural Order, on February 7, 2007, a procedural conference was scheduled to
15 commence on February 22, 2007, at 1:30 p.m., and the Commission's Utilities Division ("Staff") was
16 ordered to file by February 15, 2007, a memorandum in this Docket indicating which, if any, of the
17 above named Respondents filed its 2004 Utilities Division Annual Report subsequent to Decision No.
18 69237, so that they could be dismissed from the proceeding.

19 From February 8-14 2007, the Commission's Utilities Division Staff ("Staff") filed
20 memorandums requesting that the following Respondents be dismissed from the Complaint: Better
21 World Telecom; D-Tel; Harbor Communications, LLC; Jake's Corner Water System; Lake Verde
22 Water Company; Rural West – Western Rural Broadband, Inc.; Motion Telecom, Inc.; Teligent
23 Services, Inc.; Southwest Energy Solutions, Inc.; and Transcommunications, Inc.

24 On February 22, 2007, a procedural conference was held. Staff appeared through counsel.
25 No Respondents appeared. The Staff memorandum was discussed along with the scheduling for a
26 hearing in this matter.


27 Accordingly, a hearing should be scheduled and deadlines should be set.
