

**COMMENTS OF WWC LICENSE LLC ON THE  
SECOND SUPPLEMENTAL STAFF REPORT**

**AND**

**REQUEST THAT RECOMMENDED OPINION AND  
ORDER BE HEARD AT APRIL 11, 2007 OPEN MEETING**

WWC License LLC (“WWC-Alltel”)<sup>1</sup> hereby responds to the Second Supplemental Staff Report (“Supplemental Staff Report”) on January 28, 2007. WWC-Alltel further requests that the Commission consider the Recommended Opinion and Order (“ROO”) at its April 11-12, 2007 Open Meeting.

WWC-Alltel has reviewed the Supplemental Staff Report and does not take exception to any of the six recommended requirements offered by Staff as additional conditions for Eligible Telecommunications Carrier (“ETC”) designation. As set forth in its Notice of Withdrawal of Exceptions, WWC-Alltel recognizes the important role and obligations that flow from being an ETC in Arizona. The Company is willing to abide by the conditions set forth by

1 the ALJ in the August 23, 2005, ROO, and it is further willing to abide by the six additional  
2 recommendations set forth by Staff in the Supplemental Staff Report. The Company is  
3 confident that it can comply with both the ROO and the Supplemental Staff Report.  
4 Furthermore, WWC-Alltel does not oppose amending the ROO to incorporate the six  
5 recommendations in the Supplemental Staff Report.

6 WWC-Alltel respectfully requests that an amended ROO be issued to be considered at  
7 the April 11-12, 2007 Open Meeting.
