Tucson Electric Power Company and UNS Electric, Inc. (collectively "UniSource"), through undersigned counsel, submit the following supplemental comments on Staff's Fourth Annual Biennial Transmission Assessment, upon request by Arizona Corporation Commission Staff ("Staff").

Specifically, UniSource provides additional comments to Finding of Fact Paragraph 7.2.e. regarding filing updated RMR Studies in Santa Cruz and Mohave County, based on subsequent discussions between Commission Staff and Western Area Power Administration ("WAPA"). UniSource has since been informed, by Staff, that WAPA will provide all necessary information for compilation of the RMR Studies. Therefore, assuming that WAPA timely and fully provides the necessary information, UniSource is prepared to file an updated RMR Study for Mohave County, as well as for Santa Cruz County, in January of 2008. The language of the Proposed Order - at Finding of Fact 7.2.e. - is thus acceptable to UniSource with the understanding as described in


