

**PUBLIC NOTICE OF HEARING ON THE APPLICATION OF ARIZONA-AMERICAN WATER COMPANY FOR INCREASES IN ITS RATES AND CHARGES FOR UTILITY SERVICE BY ITS SUN CITY WASTEWATER AND SUN CITY WEST WASTEWATER DISTRICTS**

**DOCKET NO. WS-01303A-06-0491**

On July 28, 2006, Arizona-American Water Company ("Company") filed an application with the Arizona Corporation Commission ("Commission") for an increase in operating income for its Sun City Wastewater District of approximately 35.84 percent (\$1,606,636), and for its Sun City West Wastewater District of approximately 51.50 percent (\$2,337,140). Under the Company's volumetric rate design proposal, a typical residential customer's bill for wastewater service in the Sun City Wastewater District would increase from the current rate of \$10.98 per month to approximately \$15.01 per month (approximately 36.7 percent), depending on usage, and in the Sun City West Wastewater District would increase from the current rate of \$20.56 per month to approximately \$33.60 per month (approximately 63.42 percent), depending on usage. The Commission's Utilities Division Staff has not yet made a recommendation regarding the Company's rate increase proposal, and the Commission will determine the appropriate rate relief to be granted based on the evidence of record in this proceeding. The Commission is not bound by the proposals made by the Company, Staff, or any intervenors and, therefore, the final rates approved in this docket may be lower or higher than the rates described above. Copies of the application and proposed tariffs are available at the Company's offices, 15626 N. DeWitt Blvd, Sun City, Arizona and on the internet via the Commission website ([www.azcc.gov](http://www.azcc.gov)) using the e-docket function.

The Commission will hold a hearing on this matter beginning August 23, 2007, at 10:00 a.m., at the Commission's offices, 1200 West Washington, Phoenix, Arizona. Public comments will be taken on the first day of the hearing.

The law provides for an open public hearing at which, under appropriate circumstances, interested parties may intervene. Intervention shall be permitted to any person entitled by law to intervene and having a direct and substantial interest in the matter. If you desire to intervene, you must file a written motion to

intervene with the Commission no later than May 15, 2007. You must send a copy of the motion to intervene to the Company or its counsel and to all parties of record. Your motion to intervene must contain the following:

1. Your name, address, and telephone number and the name, address and telephone number of any party upon whom service of documents is to be made if not yourself.
2. A short statement of your interest in the proceeding (e.g., a customer of the Company, a shareholder of the Company, etc.).
3. A statement certifying that you have mailed a copy of the motion to intervene to the Company or its counsel and to all parties of record in the case.

The granting of intervention, among other things, entitles a party to present sworn evidence at the hearing and to cross-examine other witnesses. However, failure to intervene will not preclude any interested person or entity from appearing at the hearing and providing public comment on the application or from filing written comments in the record of the case. You will not receive any further notice of this proceeding unless you request it.


