**2<sup>ND</sup> INSUFFICIENCY LETTER**

Dear Mr. Hodges:

The application of Johnson Utilities L.L.C. to extend its Certificate of Convenience and Necessity, Docket No. WS-02987A-06-0667, still has not met the sufficiency requirements as outlined in the Arizona Administrative Code (“A.A.C.”). To correct the deficiencies, please provide the following information:

1. The submitted wastewater flow was 1.58 MGD in October 2006 for Section 11’s WWTP. If the proposed Walker Butte Unit 1 where 1,103 gallons per minute flow (approx. 1.588 MGD) will be directed to Section 11’s WWTP, the total flow would be approximately 3.168 MGD which exceeds Section 11’s capacity of 2.0 MGD. Please explain.
2. Section 2.0 of the submitted Attachment 9, the Preliminary Water and Sewer Report for Monterra, dated January 2007, states that “Sewer service for Monterra will ultimately be owned by the Town of Florence”. Please explain.
3. Please provide a copy of the Arizona Department of Water Resources Designation of Assured Water Supply for Johnson Utilities which covers Pinal AMA.

Pursuant to A.A.C. R14-2-411(C)(3), Staff may terminate an application if the applicant does not remedy all deficiencies within 60 calendar days of the notice of deficiency.
