**PROCEDURAL ORDER**

On November 4, 2005, the Arizona Public Service Company ("APS") filed an application with the Arizona Corporation Commission ("Commission") for a rate increase and to amend Decision No. 67744 (April 7, 2005).

On February 28, 2007, the Utilities Division Staff ("Staff") filed Late-Filed Exhibit S-50, Staff's final version of its proposed Plan of Administration for the Power Supply Adjustor.

On March 12, 2007, APS filed a letter stating that it did not object to the admission of Late-Filed Exhibit S-50, but that Late-filed Exhibit S-50 introduced new language and that all parties should have an opportunity to file written comments to Late-Filed Exhibit S-50 by March 26, 2007.

Accordingly, good cause has been shown and APS' request should be granted. All parties


