On March 13, 2007, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against Alonzo Russell dba Guardian Angel Advisors ("GAA") and Linda Russell, husband and wife (collectively "Respondents"), in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of investment contracts

Respondents were duly served with copies of the Notice.

On March 26, 2007, Respondents filed a request for a hearing.

Accordingly, a pre-hearing conference should be held on the allegations contained in the Notice.
