**NOTICE OF FILING  
STAFF'S ANNUAL SYSTEM  
IMPROVEMENT SURCHARGE  
AUDIT**

On June 29, 2006, the Arizona Corporation Commission ("Commission") issued Decision No. 68826 in the matter of the application for approval of the sale and transfer of utility assets for the Miracle Valley Water Company, Inc., Cochise Water Co., Horseshoe Ranch Water Company, Crystal Water Company, Mustang Water Company, Coronado Estates Water Company, and Sierra Sunset Water Company, (collectively the "McLain Systems" or "Systems") to the Northern Sunrise Water ...



1 Company and Southern Sunrise Water Company (collectively "Sunrise") and cancellation of the  
2 McLain Systems' Certificates of Convenience and Necessity.

3 In the ordering paragraph, Commission Staff ("Staff") was directed to perform an audit of the  
4 collection and expenditure of the System Improvement Surcharge ("SIS") approved in Decision No.  
5 68667. Decision No. 68667 directed Staff to perform an annual audit of SIS fund expenditures  
6 including an on-site record and infrastructure review to be filed with the Commission each April 1  
7 beginning with April 1, 2007.

8 During the course of evaluating the Sunrise application for approval of the sale and transfer of  
9 the McLain Systems' utility assets, Staff performed an audit and filed its results as part of the Staff  
10 Report filed May 17, 2006 for the above captioned application. As noted in the Staff Report, Staff  
11 recommended and will be performing an additional SIS audit by July 1, 2007 as part of the close out  
12 audit discussed in the Staff Report. Such audit would encompass the period from the inception of the  
13 SIS to the closing of the sale and will be filed in this consolidated docket.
